



LANDLORD FEES SCHEDULE

ADDITIONAL NON-OPTIONAL FEES AND CHARGES

PRE-TENANCY FEES (ALL SERVICE LEVELS)

Arranging and facilitating statutory compliance if not provided on instruction by the landlord or undertaken by the landlord within 2 weeks of instructions:

- Energy Performance Certificate (EPC): £60-90 (inc. VAT) per tenancy (cost depends on size of property)
- Gas Safety Certificate (GSR): £85 (inc. VAT) per tenancy
- Handling local authority licensing application: £150 (inc. VAT) per tenancy (NB this does not include the cost of the licence)

START OF TENANCY FEES (HMOs)

Set-up Fee:

Room let: £130 (inc. VAT) per tenancy. A 5 bed HMO which is let to 5 different tenants on individual tenancy agreements will therefore be £130 x 5.

Group/student let: £120 (inc. VAT) per tenant on the tenancy agreement. A 5 bed student HMO let on a single AST (to 5 students) will therefore be £120 x 5.

The set up fee covers marketing (excluding professional photos/videos), conducting viewings, obtaining feedback from viewings, progressing tenancy applications, referencing for tenants (ID

checks, Right-to-Rent check, financial credit checks, obtaining references from current or previous employers/landlords and any other relevant information to assess affordability) as well as contract negotiation (amending and agreeing terms) and arranging the signing of the tenancy agreement, as well as registering the deposit with a Government-authorised Scheme and providing the tenant(s) with the Deposit Certificate and Prescribed Information within 30 days of the tenancy start date.

Guarantor Fees: £30 (inc. VAT) per guarantor. Covering credit referencing and preparing a Deed of Guarantee (or as part of the Tenancy Agreement).

Inventory Fees: £100 (inc. VAT) for an inventory of the whole house. £20 (inc. VAT) for an inventory of the bedroom only.

Videography: walkthrough videos included as standard within the Set-up fee.

3d Matterport scanning/hosting (optional): £150 (inc. VAT) for scanning a property up to 5 bed HMO. £200 (inc. VAT) for scanning a property up to 7 bed HMO.

Hosting fee: £20 per month for every month that the scan is hosted on Matterport platform.

Landlord Withdrawal Fees (before move-in): £150 (inc. VAT) per tenancy. To cover the costs associated with the marketing, advertising and tenancy set-up should the landlord withdraw from the tenancy before it has started.

DURING TENANCY FEES (HMO)





LANDLORD FEES SCHEDULE

Monthly management commission: 12% of rent due (inc. VAT). For the avoidance of doubt the management commission is due in full regardless of whether the Tenant pays the rent or not.

Additional Property Visits for managed properties: £50 (inc. VAT) per visit. We will carry out inspections of the communal areas every month, and inspections of the bedrooms every 3-6 months, but should the landlord request additional property visits, this covers the costs of attending the property and completing an inspection form.

Renewal Fees: £90 (inc. VAT) per tenant on the tenancy agreement. Contract negotiation, amending and updating terms and arranging for the signing of a further tenancy agreement if requested by either party and agreed by both parties.

Landlord Withdrawal Fees (during first 12 months of tenancy only): £300 (inc. VAT) per tenancy. To cover the costs associated with advising the tenant on the change and the position of the security deposit, transferring the security deposit to the landlord or new agent, notifying all utility providers and local authority (where necessary) and returning all relevant documents held by the agent to the landlord.

Arrangement Fees for works over £1,000: 10% of cost (inc. VAT). Arranging access and assessing the work with any contractors, agreeing a Specification of Works with the landlord and ensuring work has been carried out in accordance with the Specification

of Works and retaining any resulting warranty or guarantee.

END OF TENANCY FEES, OTHER FEES AND CHARGES

Check-out Fees: £0 – included in the management commission. Attending the property to undertake an updated Schedule of Condition based on the original inventory and negotiating the repayment of the security deposit.

Court Attendance Fees: £80 (inc. VAT) per hour.

Arrangement Fees for refurbishments over £1,000: 10% of cost (inc. VAT). Arranging access and assessing the work with any contractors, agreeing a Specification of Works with the landlord and ensuring work has been carried out in accordance with the Specification of Works and retaining any resulting warranty or guarantee.

FINANCIAL CHARGES

Submission of Non-Resident Landlords receipts to HMRC: £75 (inc. VAT) quarterly. To remit and balance the financial Return to HMRC on both a quarterly and annual basis.

Additional HMRC Reporting Fees: £75 (inc. VAT) per request. Responding to any specific queries relating to either the quarterly or annual Return from either the landlord or HMRC.
